While cultural competence and biases are areas that counselor previously addressed during their own counselor training, backlash from culturally different clients who have yet to address their own is common. This program examines theories, research, and pedagogy for counseling and teaching culturally different clients and students. Exploration of cultural biases in the existing theories and current research is encouraged throughout this experience. Participants will actively participate in experiential approaches designed to develop a higher skill base and advocacy skills when working with and teaching individuals from diverse backgrounds. Participants in this course will also be equipped with culturally competent best practices.

Objectives:

- Describe the personal, environmental, and sociopolitical context of clients who are culturally different. Demonstrates fairness, equity, and sensitivity to a diverse community.
- Demonstrate knowledge of attitudes, values, and behaviors of multicultural groups and factors that influence these.
- Gain knowledge of diversity issues including cultural, disability, gender, sexual orientation, and aging issues.
- How to promote sensitivity to cultural differences of familial groups being counseled

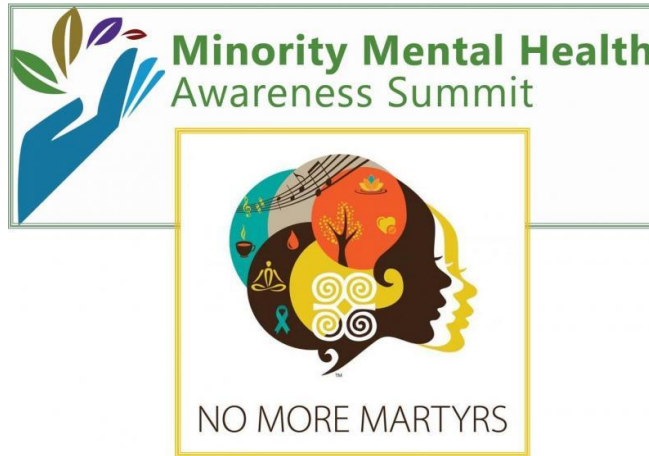


Asha Dickerson, Ph.D., NCC, LPC
